#65-16 Transfer of \$106,676.39 to the Fire Department to install amplifying cable.

HIS HONOR THE MAYOR, requesting authorization to transfer the sum of one hundred six thousand six hundred seventy-six dollars and thirty-nine cents (\$106,676.39) from Free Cash to a Fire Department Capital Account to fund the installation of bi-directional amplifying cable for Police and Fire Department radio

coverage inside Newton South High School. [02/09/16 @ 2:47 PM]

**Note:** Chief Proia, Captain Dowling and Mr. Yee joined the Committee for discussion on

this item.

Chief Proia stated that this appropriation will fund the installation of an amplifying cable at the Newton South High School allowing the Fire and Police Departments to better communicate within the school building with the Dispatch Bureau which currently has limited capabilities.

This quote is based on testing performed and recommendations made by All-Comm Technologies, Inc. A radio communication system was installed at the Newton North High School by All-Comm Technologies, Inc. for the Police and Fire Departments that has worked very well. It is necessary to have better communication in school buildings.

Captain Dowling stated that All-Comm Technologies, Inc. was contacted approximately one-year ago to address concerning issues and weak radio transmissions at the Newton South High School.

#### **Committee Questions:**

Is the proposed amplifying cable system suitable for Newton South High School? Please describe the system and installation process?

When do you anticipate installing the system?

Have all schools been inspected on radio communication with the Fire and Police Departments communicating with the Dispatch Bureau?

Does this system allow the Fire and Police Departments personnel to communicate to each other?

Mr. Yee answered that the system is suitable for Newton South High School and explained that if additional weak areas are found, the system can be adjusted to better control communication without difficulty. The system includes a battery backup. The amplifier system cables will be run throughout the building above the ceiling.

Chief Proia stated that All-Comm Technologies, Inc. determined that there were approximately twenty bad communication areas in the school where transmissions were not desirable. The gym and field house do not need any additional amplification. It is necessary in the school due to the type of windows and steel structure. All schools are in the process of being inspected to address radio communications; this is now a requirement in all new buildings during Fire Department occupancy testing prior to being issued a certificate of occupancy permit.

It is Chief Proia intent that this amplifying cable system will be installed in summer 2016.

Without further discussion, Councilor Lipof made a motion to approve this appropriation. Council members agreed 6-0.

#### Increase the number of Chief of Operation positions in the Fire Department


