RE: Discussion of West Newton Square Enhancements Project

MEETING DATE: January 3, 2017

The West Newton Square Enhancements Project is the second village enhancements project, after Auburndale Square, and the first to be completed in conjunction with the Complete Streets Policy and Newton-in-Motion, the Transportation Strategy. The West Newton Square project started with an identified need to upgrade traffic signals and became a broader effort to improve safety and enhance the village character. The plan has developed with robust input from the West Newton community and businesses and with the guidance of the three Ward 3 Councilors.

On January 3rd, the design team will present the recommended concept plan. The presentation will walk through the goals, the process, and the plan that resulted, with a breakdown of how the plan affects walking and shopping, parking, biking, and driving through the square.

At this time we are not seeking a vote, but are asking for your thoughts and reactions. The recommended concept has been thoroughly reviewed by West Newton residents and businesses, and we seek to show you the conceptual plan before carrying it through to detail design. Votes on this



plan will be sought from the Public Facilities, Public Safety and Transportation, and Finance Committees once a detail design plan and budget are complete.

Project Goals

From the outset, the project has had the following goals:

- Maximize safety and convenience for all travel modes
- Enhance Pedestrian Experience / Village Character / Business Climate
- Benefit the Environment

Safety is the first and foremost concern for this project. The Transportation Strategy research identified West Newton as a crash hotspot, particularly for crashes involving pedestrians and/or bicyclists. MassDOT has actually identified West Newton as one of the top 5% worst crash locations for pedestrians and bicyclists in the Boston metro region.

Additionally we heard time and again that West Newton Square feels like a highway on-ramp, when it is in fact a vibrant village center and a regional destination for arts, culture, dining, and business. This project is an opportunity to enhance the village character, make it easier to walk between businesses, and still accommodate through traffic. In addition to hard infrastructure, this project intends to restore the tree canopy and landscaping. Wherever possible, the design team is looking to 21st techniques that will give plantings the best chances for survival, including looking at linking plantings with stormwater management.

Process to Date

This project has benefitted from robust community involvement. There have been three phases of public involvement to this point.

In the first phase (June-August), we asked, "What do we need to know?"

- ~ 10 people sent in inspiration photos of places they'd been and things they'd be interested in seeing in West Newton.
- 80+ people came to the evening workshop, wrote down ideas, and pointed out issue areas.
- 40+ people came to a site walk to show the design team specific things
- 125 comments were submitted on an online map
- 35+ business visits were conducted to hear from owners and clerks.

In the second phase (Sept-Oct), we presented two concept plans and asked, "What do you think of the options?"

- 80+ people came to the evening workshop, asked questions, and wrote down comments
- 57 comments were submitted on the online map
- 66 emails were sent in with detailed commentary
- 15-20 businesses attended a business meeting
- 25+ follow up business visits were conducted

In the third phase (Nov-Dec), we presented the recommended concept to the West Newton community and businesses. In these meetings we have heard overwhelmingly positive feedback and excitement. On January 3rd, we will present the same recommended concept to the City Council and ask for your thoughts.

Next Steps:

Following the upcoming meeting on January 3rd, this project will transition into detail design during which the concept will be developed into detailed construction drawings, materials and fixtures will be selected and budgeted, and bid documents prepared. During this time, there will be additional opportunity for public involvement. This phase will culminate in presentation to the City Council again for adoption of the plan and budget.

Construction on this project is broken into two phases: infrastructure rehabilitation and enhancements construction. The first phase is to rehabilitate the gas main below Washington Street. National Grid is already aware of the enhancements project and is preparing to begin their work in Spring 2017. The enhancements construction would begin after the gas line work is complete in Late Summer 2017.


