Washington Place Follow Up Information & Vote – Please refer to the *updated* information in this week's packet regarding the project. *Both* this updated packet of information and the *previously supplied answers* to your questions from our last full Council meeting are in the current *online* packet. **Both the re-zoning request and special permit are before the Council this Monday, June 19th for a vote.**

- **Parks & Recreation Awards** – *All Council members are invited to attend.* The Parks & Recreation Commission will be hosting their annual awards on **Monday, June 19th at 7:00p.m.** in the Chamber prior to our full Council meeting.
- **Full Council Meeting** – The Council will be meeting on **Monday, June 19th at 7:45p.m.** in the Chamber. *At the end of first call we will recognize: Anthony B. Salvucci Scholarship recipients; high school students going into the military; Newton North and Newton South Science Olympiad Teams; Newton Southeast Little League Red Sox Team and their Coach Jerry Sack for their championship win and Jerry's 43 years of Little League coaching. Additionally, item #82-17 - citizen's petition requesting a resolution for Presidential impeachment inquiry – has been placed on second call. I have been informed the item will be chartered. It will be back before the Council on Monday, July 10th.*

Redevelopment; #200-17 \$875,000 to fund the Accelerated Roads Program; Chairs Note: The Chair's will discuss updates to pending agenda items. The Intention is to NAN the following items: #384-16 Appropriate \$71,000 to build an observation deck on the greenway; #27-16 Updates from the Administration on the renovations at the Aquinas site; #59-17 Appropriate \$350,000 for construction of a Parks & Recreation/Police building; #206-16 Resolution requesting the administration hire a composting expert; #207-16 Review of the management of the Rumford Avenue site and; #208-16 Update on fire prevention at the compost operation at Rumford Avenue Landfill
