On Friday, Jan. 3, 2020 at 4:29pm, the Newton City Council Docket was revised for the Council meeting scheduled for 7:00pm on Monday, Jan. 6, 2020 by adding an item regarding discussion of the Referendum Petition requesting that the City Council repeal or rescind Council Order #425-18. The notice was not posted 48 business hours prior to the meeting, nor was it posted in a conspicuous manner.

This notice knowingly violated the Open Meeting Law, MGL c. 30A, section 20, which states, in pertinent part:

"(b)...a public body shall post notice of every meeting at least 48 hours prior to the meeting, excluding Saturdays, Sundays, and legal holidays....Notice shall be printed in a legible, easily understandable format and shall contain the date, time and place of the meeting and a listing of the topics that the chair reasonably anticipates will be discussed at the meeting.

(c) For a meeting of a local public body, notice shall be filed with the municipal clerk and posted in a manner conspicuously visible to the public at all hours in or on the municipal building in which the clerk's office is located."

As a result of the Open meeting Law violation:

- \* The public was deprived of the required 48 hours notice of the item under discussion.
- \* The public was deprived of notice of the Council's Jan. 6 vote on whether to convene as a Committee of the Whole on Jan. 8 to discuss the Referendum Petition.
- \* The Referendum Petition was and is of great importance to a large number of Newton registered voters, over 5,000 of whom signed the Referendum Petition.
- \* The lack of notice deprived the public of the opportunity to hear the debate concerning whether the Council would repeal or rescind the action protested by the Referendum Petition and the debate concerning the date to hold the vote on a referendum in the event that the Council failed to repeal or rescind the Council Order protested in the Referendum Petition.

What action do you want the public body to take in response to your complaint?

Nullify the actions taken by the Council on Monday, Jan. 6, 2020 regarding the Referendum Petition and any related actions taken on Wednesday, Jan. 8, 2020;

Redocket the item in question 48 hours prior to a Council meeting and reconvene the Committee of the Whole to discuss the Referendum Petition and refer its recommendation to the Council;

Compel immediate and future compliance with the Open Meeting Law;

Compel attendance at a training session authorized by the Massachusetts Attorney General.
